

The End of Life Revisited **Saturday, March 20th, 2010**

Overview

The main objective of this symposium is to provide physicians and other health care professionals with the skills to deal with ethical dilemmas in the treatment and care of patients who may be near the end-of-life.

The symposium will also explore challenges in improving end-of-life care. It will include several international perspectives and comparison with practices in the US. It will also include perspectives on two controversial topics: the duty of care during public health emergencies with respect to patients who may be near the end of life, and discussions over the practice of euthanasia in the Netherlands and physician-assisted suicide in several US states.

Faculty includes local faculty, invited speakers from the Hastings Center, and professors from Chile, Brasil, Italy, the Czech Republic and the Netherlands. The symposium offers CME credits, and is open to students of medicine, nursing, and other health care professions.

Objectives

At the end of the symposium, participants will be prepared to:

1. Describe the ethical goals of good care near the end-of-life, and the professional competencies that support the practice of good care and the resolution of ethical dilemmas.
2. Discuss how interdisciplinary palliative care can be integrated into different treatment frameworks, patient populations, and care settings near the end-of-life.
3. Describe the legal context of end-of-life care, and identify and correct legal myths.
4. Recognize the role of personal, cultural, spiritual, and religious values in decision-making and care near the end-of-life.
5. Find and evaluate institutional and web resources.
